ZONING AND CODES:

Lexington Point:

The Township has reviewed and issued building permits for 4 new homes for Lexington Point, homes #7 - #10. Three additional permits have been submitted reviewed for three more homes in the development and will be issued upon compliance with the required SSTP Milestones.

Oak Tree Ln. - Zoning Enforcement (Chickens and Goats):

This Zoning Violation is now a Civil Citation and has been filed with the District Court (DC). The DC has set a hearing date for 8/1 at 1 pm. The Solicitor and I will appear before the DC on that date.

Bamboo Complaint:

I'm working with a resident with bamboo encroaching on a neighboring property. The resident is planning to install subsurface barrier protection to limit the spread of the bamboo. **UPDATE: The property owner is currently remediating the Bamboo.**
